I further state that the said child is in proper physical condition to participate in horseback riding and/or sleigh rides and/or wagon rides and/or the use of **Isner Stables Limited's** horses, equipment and facilities and I am aware that participation could, in some circumstances, result in physical injury.

Protective Head Gear & Foot Wear:

1. Proper footwear is required by all persons, regardless of age, who participate in horse riding and/or wagon rides. No open toe, high heel shoes or bare feet are permitted;
2. All minors (horse back riders under 19 years of age) are required to wear protective head gear in the form of a high impact helmet and aforementioned proper foot wear;
